Delivery and Return of Work: All work submitted must arrive ready to install. Work may be hand delivered or shipped. Shipped works must be sent in an easily reusable container/packaging with return shipping prepaid. Works will be returned in the same manner as delivered or via UPS/USPS. All work must arrive at The Art Center by the specified date (see deadlines). Accepted work will remain on display for the duration of the exhibition. Works that are not juried into the show can be picked up on September 25th, 2009 from 11am to 3pm at TAC II located at 111 E. Bay St. All will be notified by email upon acceptance or rejection.

Insurance: Artist is responsible for insuring their own art work. Also not covered is damage caused to work by failure of the work itself, or its mounting systems installed by the artist. Number of entries is unlimited. Entry fee must be paid by check or money order made payable to The Art Center Coop., Inc. All work, unless indicated as not for sale (NFS), will be available for sale during exhibit. The Art Center Coop., Inc. will retain a commission of 30% on all artwork sold during the exhibition.
